European framework for research careers approved by the Council

Under the Spanish Presidency of the EU Council, the Ministers of Science and Technology of the European Union approved the Recommendation on a European framework to attract and retain research, innovation and entrepreneurial talents in Europe. The Recommendation sets new guidelines and initiatives to promote researchers' working conditions, fostering inter-sectoral mobility and addressing persisting inequalities in research careers, contributing to the consolidation of the European Research Area (ERA). The recommendation includes a revised definition of "researcher" and its categorization in four profiles, from R1 to R4; a revised update of the skills and competences of researchers, entitled RESEARCHCOMP; the inclusions of research managers within the spectrum of research professions; and a revised European Charter for Researchers.

New expert group for the interim evaluation of Horizon Europe

The European Commission has nominated a group of experts to carry out the interim evaluation of the largest framework programme for research and innovation (R&I) in Europe, Horizon Europe. The group is chaired by Manuel Heitor, from University of Lisbon and former Minister of Science, Technology and Higher Education in Portugal. The experts will produce a report on the value-added of the current framework programme for R&I. This work will also contribute to the design of the future European framework programme for research and innovation.

ICoRSA Conference "Addressing Addressing Researcher Career Precarity in Portugal: perspectives from EU countries" took place last January 12 and gathered a total of 116 participants.

ICORSA at UNESCO 5th International Forum of NGOs in official partnership with UNESCO on "Transforming Mentalities".

The 15th International Forum of NGOs in official partnership with UNESCO showcased examples of good practices to address inequalities and build concrete recommendations for action at the local level. Besides the local initiatives presented by NGOs, UNESCO presented current gender programmes and the future Initiative the Freedom and Safety of Scientific Researchers as part of UNESCO's 2017 Recommendation on Science and Scientific Researchers (RSISR), currently on ongoing consultation process. The Freedom and Safety of Scientific Researchers will promote a space for dialogue between science advisors and the scientific community, data collection analysis and institutional capacities.

Research and Innovation Days 2024

Policymakers, researchers and representatives of stakeholder institutions gathered in Brussels from March 18 to 21, 2024, to discuss recent trends in Research and Innovation. The science policy high-level event organized by the European Commission celebrated the 40th anniversary of the European Research and Innovation Framework Programmes. The three-day event included the Research and Innovation Days, the EIC Summit 2024 and the Belgian Presidency Conference on Innovation Procurement.

The event also Included discussions on the future of the main funding programme in Europe, the Framework Programme for Research and Innovation (FP10). Main messages include the need for more fundamental research with less prescription of science, simplification, budget stability and autonomy in programming during the all period of the framework programme.

ISE Recommendations for Horizon Europe and FP10 with participation of ICoRSA

Initiative for Science in Europe (ISE), an advocacy group in Europe that gathers stakeholders' organizations as ICoRSA, EURODOC, Young Academy Europe and individual researchers, launched in 2024 its recommendations on Horizon Europe and FP10, the European major framework programmes for Research and Innovation. The recommendations include contributions from ICoRSA and from its Research Staff Associations ANICT and NInTEC.

Key recommendations include (i) a call to increase collaborative basic research to complete the Research and Innovation cycle in Pillar 2 of Horizon Europe, (ii) avoid any budget cut of Pillar 1 (including the European Research Council grants and Marie Curie Actions) during the remaining years of Horizon Europe, and (iii) increase its budget in the upcoming framework programme.
